Patient Care - <i>Clinical Judgment</i>	Sentinel events, with PA-specific action items as a result of RCA process	Screen from indicators	One case within six-month period -letter to be sent; additional case at 12 months triggers FPPE.
<i>Medical/Clinical Knowledge</i>	Failure to recognize abnormal diagnostics	Referral from internal source, chart abstraction	Three cases in a six-month period
<i>Interpersonal and Communication Skills</i>	Satisfaction scores or survey of peers	HCAHPS/complaint-driven referral or direct survey of peers	Two standard deviations in the sub-optimal direction from department mean based on indicator
<i>Professionalism</i>	Patient or staff member behavioral complaints against practitioner	Referred internally (patient advocate, risk manager, director of nursing, etc.)	One case within six-month period - letter to be sent; additional case at 12 months triggers FPPE.
<i>Practice-Based Learning and Improvement</i>	Core measure compliance - ATB stop <24hrs surgery - Beta blocker continuance	Current chart abstraction	One standard deviation in the sup-optimal direction from department mean based on indicator
